

ORDINANCE NO. 10570 MAY 6 1971
(New Series)

AN ORDINANCE INCORPORATING PORTIONS OF
LOT 67, RANCHO MISSION, IN THE CITY OF
SAN DIEGO, CALIFORNIA, INTO LC ZONE,
AS DEFINED BY SECTION 101.0454 OF THE
SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San
Diego, as follows:

Section 1. That portions of Lot 67, Rancho Mission,
in the City of San Diego, California, within the boundary
of the district designated "LC" on Zone Map Drawing No.
C-298, filed in the office of the City Clerk as Document
No. 735299 be, and they are hereby incorporated into
LC Zone, as such zone is described and defined by Section
101.0454 of the San Diego Municipal Code.
