

ORDINANCE NO. 10572 MAY 6 1971  
(New Series)

AN ORDINANCE INCORPORATING PORTIONS OF CLAIREMONT PLAZA UNIT 3, AND CLAIREMONT GARDEN; PORTIONS OF PUEBLO LOTS 1176, 1177, 1179, 1189, 1190, 1191, 1195, 1196, 1197, 1204, 1205, 1206, 1207, 1210, 1211, 1222, 1223, 1224, 1227, 1228, 1229, AND 1236; PORTIONS OF UNNUMBERED PUEBLO LOT (CONNOR'S TRACT) AND BLOCK 14, C.C.C. TATUM'S BAY HILLS MESA; PORTIONS OF TECOLOTE HEIGHTS, MISSION BAY HEIGHTS, AND A PORTION OF MORENA; AND PORTIONS OF PUEBLO LOTS 265, 267, 289, 291, AND 292, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO LC ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Clairemont Plaza Unit 3, and Clairemont Garden; portions of Pueblo Lots 1176, 1177, 1179, 1189, 1190, 1191, 1195, 1196, 1197, 1204, 1205, 1206, 1207, 1210, 1211, 1222, 1223, 1224, 1227, 1228, 1229, and 1236; portions of Unnumbered Pueblo Lot (Connor's Tract) and Block 14, C.C.C. Tatum's Bay Hills Mesa; portions of Tecolote Heights, Mission Bay Heights, and a portion of Morena; and portions of Pueblo Lots 265, 267, 289, 291, and 292, in the City of San Diego, California, within the boundary of the district designated "LC" on Zone Map Drawing No. C-297.1, filed in the office of the City Clerk as Document No. 735298 be, and they are hereby incorporated into LC Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.
