

ORDINANCE NO. 10573 MAY 6 1971
(New Series)

AN ORDINANCE INCORPORATING BLOCKS 81, 82 AND 114 AND LOT 150, PORTIONS OF BLOCKS 70, 72, 83 AND 105 AND PORTION OF LOT 151, MORENA; PORTION OF LOT 7, EUREKA LEMON TRACT, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO LC ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Blocks 81, 82 and 114 and Lot 150, portions of Blocks 70, 72, 83 and 105 and portion of Lot 151, Morena; portion of Lot 7, Eureka Lemon Tract, in the City of San Diego, California, within the boundary of the district designated "LC" on Zone Map Drawing No. C-295.1, filed in the office of the City Clerk as Document No. 735296 be, and they are hereby incorporated into LC Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.
