ORDINANCE NO. (New Series) MAY 6 1971

AN ORDINANCE INCORPORATING BLOCKS 81, 82 AND 114 AND LOT 150, PORTIONS OF BLOCKS 70, 72, 83 AND 105 AND PORTION OF LOT 151, MORENA; PORTION OF LOT 7, EUREKA LEMON TRACT, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO LC ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:
