ORDINANCE NO. (New Series)

AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 7, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 67.58 RELATING TO WATER RATES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 7 of the San Diego Municipal Code be amended by amending Section 67.58 to read as follows:

SEC. 67.58 WATER RATES--FIRE HYDRANT SERVICE WITHIN THE CITY OF SAN DIEGO

The rate to be so charged and collected for Fire

Hydrant Service within the City (which shall include

maintenance of the hydrant in accordance with the pro
visions of the Uniform Fire Code as adopted by Section 55.1

of the Municipal Code, and water used for fire extin
guishing purposes) shall be as follows:

Rate Schedule:

Flat rate.

For each such fire hydrant located on City property--\$6.00 per annum.

For each such fire hydrant located on private property--\$20.00 per annum.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
