

ORDINANCE NO. 10575 MAY 6 1971  
(New Series)

AN ORDINANCE ESTABLISHING THE SPECIAL  
ENVIRONMENTAL GROWTH FUND

WHEREAS, The City of San Diego has granted certain franchises for the transmission and distribution of gas, electricity and steam and derives certain sums of money by way of franchise fees paid for these privileges; and

WHEREAS, funds to be used for preserving and enhancing the environment of the City may be set aside; and

WHEREAS, certain private donations may be received which are specifically designated for the purposes of preserving and enhancing the environment of the City; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

1. That there is hereby established a "Special Environmental Growth Fund" in the City of San Diego.
2. That into this fund the City Auditor and Comptroller is hereby directed to place annually 25% from the revenues accruing to the City from the franchises for the transmission and distribution of gas, electricity and steam within the City of San Diego, commencing on July 1, 1971.


3. That the City Auditor and Comptroller is hereby directed to place any private donations specifically designated for environmental purposes into said fund and any other such revenues as the City Council may designate from time to time.

4. That said fund shall be used solely and exclusively for the purpose of preserving and enhancing the environment of the City and will be expended by resolution of the City Council.

5. That the City Council shall have the sole discretion in the determination of what constitutes an appropriate expenditure from said fund.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
