BE IT ORDAINED by the Council of The City of San Diego  
as follows:

Section 1. That Chapter III, Article 3 of the San Diego  
Municipal Code be and it is hereby amended by amending  
Section 33.1625.6 to read as follows:

SEC. 33.1625.6 CHARGES

No charge in excess of one dollar (\$1.00) per hour  
per player shall be collected from any player for the  
privilege of participating in any game.

Section 2. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage.
