

ORDINANCE NO. 10578
(New Series)

MAY 13 1971

AN ORDINANCE INCORPORATING PORTIONS OF PUEBLO LOTS 1107 AND 1173, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 AND CA ZONES, AS DEFINED BY SECTIONS 101.0411 AND 101.0428.1, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 1947 (NEW SERIES), ADOPTED OCTOBER 1, 1940, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, portions of Pueblo Lots 1107 and 1173, in the City of San Diego, California, designated "R-3" and "CA" on Zone Map Drawing No. B-2459, are subdivided and a final subdivision map or maps thereof duly recorded and within such subdivision or subdivisions, provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Sections 101.0411 and 101.0428.1 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into R-3 and CA Zones, as described by Sections 101.0411 and 101.0428.1, respectively, the boundary of such zones to be as indicated on Zone Map Drawing No. B-2459, filed in the office of the City Clerk as Document No. 735472. Said zoning shall attach only to those areas included in the subdivision map or maps recorded as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said subdivided land described in Section 1 of this ordinance, Ordinance No. 1947 (New Series), adopted October 1, 1940, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
