

ORDINANCE NO. 10592

AN ORDINANCE INCORPORATING PORTIONS OF PUEBLO LOTS 1210, 1211, 1207, 1206, 1195, 1223, 1222 AND PORTION OF UNNUMBERED PUEBLO LOT (CONNOR TRACT), IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-15 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13457, APPROVED FEBRUARY 15, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Pueblo Lots 1210, 1211, 1207, 1206, 1195, 1223, 1222 and portion of Unnumbered Pueblo Lot (Connor Tract), in the City of San Diego, California, within the boundary of the district designated "R-1-15" on Zone Map Drawing No. B-2426.1, filed in the office of the City Clerk as Document No. 735617 be, and they are hereby incorporated into R-1-15 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13457, approved February 15, 1932, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
