That Chapter VIII, Article 6 of the San Diego Municipal Code be and it is hereby amended by adding Section 86.09.1 to read as follows:

SEC. 86.09.1 PARKING ON PRIVATE PROPERTY--PROHIBITED

No person shall park a vehicle in a private driveway or on private property without the direct or implied consent of the owner or person in lawful possession of such driveway or property.

This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
