

ORDINANCE NO. 10617

AN ORDINANCE INCORPORATING LOTS 1 THROUGH 12, BLOCK 2, WEEKS' ADDITION, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1A ZONE, AS DEFINED BY SECTION 101.0436 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 85 (NEW SERIES), ADOPTED NOVEMBER 21, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a parcel map is recorded on Lots 1 through 12, Block 2, Weeks' Addition, in the City of San Diego, California, designated "M-1A" on Zone Map Drawing No. B-2495.1, and provided the conditions as required by the City Engineer in Document No. 736058 are met, the provisions of Section 101.0436 of the San Diego Municipal Code shall attach and become applicable to the land and said land shall be incorporated into M-1A Zone, as described by Section 101.0436, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2495.1, filed in the office of the City Clerk as Document No. 736057.

Section 2. That in the event the zoning restrictions shall attach to the land described in Section 1 of this ordinance, Ordinance No. 85 (New Series), adopted November 21, 1932, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.
