AN ORDINANCE INCORPORATING A PORTION OF ROSE CANYON CONSISTING OF: PORTIONS OF PUEBLO LOTS 1252, 1777, 1778, 1787 AND 1788; RICE SUBDIVISION; PORTIONS OF HOMELAND VILLAS, BLOCK 5; AND PORTION OF PARTITION OF PUEBLO LOT 1209, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5, M-1A AND M-IP ZONES AS DEFINED BY SECTIONS 101.0407, 101.0436 AND 101.0435.1, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCES NO. 13456, APPROVED FEBRUARY 15, 1932; NO. 100 (NEW SERIES), ADOPTED DECEMBER 12, 1932; NO. 3061 (NEW SERIES), ADOPTED SEPTEMBER 11, 1945 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

"R-1-5," "M-1A" and "M-IP" on Zone Map Drawing No. C-299.1,
filed in the office of the City Clerk under Document No. 736604
be, and they are hereby incorporated into R-1-5, M-1A and M-IP
Zones, as such zones are described and defined by Sections
101.0407, 101.0436 and 101.0435.1, respectively, of the San
Diego Municipal Code.

Section 2. That Ordinances No. 13456, approved February 15, 1932; No. 100 (New Series), adopted December 12, 1932; No. 3061 (New Series), adopted September 11, 1945 of the Ordinances of The City of San Diego be and they are hereby repealed insofar as they conflict herewith.
