AN ORDINANCE AMENDING ORDINANCE NO. 10584 (NEW SERIES), AS AMENDED, TO CREATE THE CLASSIFIED POSITION OF ASSISTANT TO THE DIRECTOR OF PUBLIC WORKS--CITY ENGINEER AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. Ordinance No. 10584 (New Series) of the ordinances of The City of San Diego, as amended, is hereby amended to create and establish the classified position of Assistant to the Director of Public Works--City Engineer.
