AN ORDINANCE AMENDING ORDINANCE NO. 10584 (NEW SERIES), AS AMENDED, TO DELETE THE UNCLASSIFIED POSITIONS OF COMMUNITY DEVELOPMENT DIRECTOR (ASSISTANT TO THE CITY MANAGER) AND CITY ENGINEER, TO CHANGE THE TITLE OF PUBLIC WORKS DIRECTOR TO READ "DIRECTOR OF PUBLIC WORKS--CITY ENGINEER," AND TO CREATE THE UNCLASSIFIED POSITIONS OF ASSISTANT TO THE CITY MANAGER (PUBLIC SERVICES), COMMUNITY DEVELOPMENT DIRECTOR, MODEL CITIES DIRECTOR, DEPUTY MODEL CITIES DIRECTOR, PUBLIC SERVICE INTERN II AND PUBLIC SERVICE INTERN I AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. Ordinance No. 10584 (New Series) of the ordinances of The City of San Diego, as amended, is hereby amended to delete the unclassified positions of Community Development Director (Assistant to the City Manager) and City Engineer and to change the title of Public Works Director to read "Director of Public Works--City Engineer."

Section 2. Ordinance No. 10584 (New Series) is further amended to create and establish the unclassified positions of Assistant to the City Manager (Public Services), Community Development Director, Model Cities Director, Deputy Model Cities Director, Public Service Intern II and Public Service Intern I.

Section 3. As a schedule of compensation for the positions created in Section 2 hereof, the following standard rate numbers of the Table of Standard Rates of Pay established and adopted

Section 5. The position of Community Development Director shall be inserted in Exhibit C of Ordinance No. 10584 (New Series), as amended, under the general category of ADMINISTRATION between the positions of Building Inspection Director and Personnel Director.

Section 6. The position of Model Cities Director shall be inserted in Exhibit C of Ordinance No. 10584 (New Series), as amended, under the general category of ADMINISTRATION between the positions of Legislative Representation Director and Assistant City Auditor and Comptroller.

Section 7. The position of Deputy Model Cities Director shall be inserted in Exhibit C of Ordinance No. 10584 (New Series), as amended, under the general category of ADMINISTRATION between the positions of City Clerk and Treasurer.

Section 8. The position of Public Service Intern II shall be inserted in Exhibit C of Ordinance No. 10584 (New Series), as amended, under the general category of INTERNS after the position Police Intern.

Section 9. The position of Public Service Intern I shall be inserted in Exhibit C of Ordinance No. 10584 (New Series), as amended, under the general category of INTERNS after the position Public Service Intern II.

Section 10. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING ORDINANCE NO. 10584 (NEW SERIES), AS AMENDED TO DELETE THE UNCLASSIFIED POSITIONS OF COMMUNITY DEVELOPMENT DIRECTOR (ASSISTANT TO THE CITY MANAGER) AND CITY ENGINEER TO CHANGE THE TITLE OF PUBLIC WORKS DIRECTOR TO READ DIRECTOR OF PUBLIC WORKS, CITY ENGINEER AND TO CREATE THE UNCLASSIFIED POSITIONS OF ASSISTANT TO THE CITY MANAGER (PUBLIC SERVICES), CITY MUNICIPAL DEVELOPMENT DIRECTOR, MODEL CITIES DIRECTOR, DEPUTY MODEL CITIES DIRECTOR, MODEL CITIES DIRECTOR, AND PUBLIC SERVICE INTERN I AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

Section 1: Ordinance No. 10584 (New Series) of the City of San Diego, as amended, is hereby amended to delete the unclassified positions of Community Development Director (Assistant to the City Manager) and City Engineer and to change the title of Public Works Director to read Director of Public Works - City Engineer.

Section 2: Ordinance No. 10584 (New Series) is further amended to create and establish the unclassified positions of Assistant to the City Manager (Public Services), Community Development Director, Model Cities Director, Deputy Model Cities Director, Public Service Intern II and Public Service Intern I.

Section 3: As a schedule of compensation for the positions created in Section 2 hereof, the following standard rate numbers of the Table of Standard Rates of Pay established and adopted by Ordinance No. 10584 (New Series), as amended, of the ordinances of said City are hereby adopted:

Section 5: The position of Community Development Director shall be inserted in Exhibit C of Ordinance No. 10584 (New Series), as amended, under the general category of ADMINISTRATION between the positions of Building Inspection Director and Personnel Director.

Section 6: The position of Model Cities Director shall be inserted in Exhibit C of Ordinance No. 10584 (New Series), as amended, under the general category of ADMINISTRATION between the positions of Legislative Representation Director and Assistant City Auditor and Comptroller.

Section 7: The position of Deputy Model Cities Director shall be inserted in Exhibit C of Ordinance No. 10584 (New Series), as amended, under the general category of ADMINISTRATION between the positions of City Clerk and Treasurer.

Section 8: The position of Public Service Intern II shall be inserted in Exhibit C of Ordinance No. 10584 (New Series), as amended, under the general category of INTERNS after the position Police Intern.

Section 9: The position of Public Service Intern I shall be inserted in Exhibit C of Ordinance No. 10584 (New Series), as amended, under the general category of INTERNS after the position Public Service Intern II.

Section 10: This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
