ORDINANCE NO. 10671 (New Series)

AN ORDINANCE SETTING ASIDE AND DEDICATING CERTAIN PORTIONS OF LANDS IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK, AND NAMING SAID PARK "MISSION BAY PARK."

WHEREAS, The City of San Diego is the owner of certain lands in the City of San Diego; and

WHEREAS, it is the desire of the people of the City of San Diego to set aside and dedicate forever portions of said lands, hereinafter described, for public use and enjoyment as and for a public park to be used by all the public for recreational purposes; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the hereinafter described real property be, and the same is hereby set aside and dedicated in perpetuity as a public park to be used by all the public for recreational purposes.

Section 2. That the hereinafter described real property be, and the same is hereby named "MISSION BAY PARK."

Section 3. That the real property so dedicated and named is described in the deeds attached hereto and marked Exhibits A and B, which deeds are on file in the office of the City Clerk as Document Nos. 736981 and 736980
