

ORDINANCE NO. 10683 SEP 14 1971
(New Series)

AN ORDINANCE INCORPORATING THAT AREA SOUTHWEST OF PINE STREET, NORTHEAST OF JUAN STREET, NORTHWEST OF WITHERBY STREET, AND SOUTHEAST OF ALTAMIRANO WAY AND HARNEY STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO LC ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That area southwest of Pine Street, northeast of Juan Street, northwest of Witherby Street, and southeast of Altamirano Way and Harney Street, in the City of San Diego, California, within the boundary of the district designated "LC" on Zone Map Drawing No. C-301.1, filed in the office of the City Clerk as Document No. 736998 be, and it is hereby incorporated into LC Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
