

ORDINANCE NO. 10690 SEP 30 1971  
(New Series)

AN ORDINANCE INCORPORATING THAT AREA WEST OF STATE HIGHWAY 163 (CABRILLO FREEWAY), BETWEEN PENNSYLVANIA AVENUE AND UPAS STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO LC ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That area west of State Highway 163 (Cabrillo Freeway), between Pennsylvania Avenue and Upas Street, in the City of San Diego, California, within the boundary of the district designated "LC" on Zone Map Drawing No. C-304, filed in the office of the City Clerk as Document No. 737000 be, and it is hereby incorporated into LC Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
