AN ORDINANCE AMENDING ORDINANCE NO. 10554 (NEW SERIES), ADOPTED APRIL 20, 1971, INCORPORATING A PORTION OF LOT 30, HORTON'S PURCHASE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, Ordinance No. 10554 (New Series), adopted April 20, 1971, rezoned a portion of Lot 30, Horton's Purchase, from R-1-5 to R-3, subject to the recordation of a final subdivision map or maps on or before March 1, 1972; and

WHEREAS, a request has been received to amend this ordinance to delete the subdivision map requirement; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 10554 (New Series), adopted April 20, 1971 be, and it is hereby amended to read as follows:

Section 1. That a portion of Lot 30, Horton's Purchase, in the City of San Diego, California, within the boundary of the district designated "R-3" on that certain Zone Map Drawing No. B-2012.1, filed in the office of the City Clerk under Document No. 726528 be, and it is hereby incorporated into R-3 Zone, as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.
