AN ORDINANCE INCORPORATING LOTS 11 THROUGH 16, BLOCK 96 OF RESUBDIVISION OF BLOCKS 96 AND 97, ROSEVILLE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 32 (NEW SERIES), ADOPTED SEPTEMBER 12, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, IN SO FAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a parcel map for lot consolidation is recorded on Lots 11 through 16, Block 96 of Resubdivision of Blocks 96 and 97, Roseville, in the City of San Diego, California, designated "CO" on Zone Map Drawing No. B-2535, and provided the conditions as required by the Community Development Director in Document No. 737421 are met, the provisions of Section 101.0423 of the San Diego Municipal Code shall attach and become applicable to the land and said land shall be incorporated into CO Zone, as described by Section 101.0423, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2535, filed in the office of the City Clerk as Document No. 737420.

Section 2. That in the event the zoning restrictions shall attach to the land described in Section 1 of this ordinance, Ordinance No. 32 (New Series), adopted September 12, 1932, of

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
