AN ORDINANCE AMENDING CHAPTER X, ARTICLE 2 OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 102.0811 RELATING TO THE APPLICABILITY OF PROVISIONS TO CHANGE OF ZONE.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Chapter X, Article 2 of the San Diego Municipal Code be amended by adding Section 102.0811 to read as follows:

SEC. 102.0811 APPLICABILITY OF PROVISIONS  
TO CHANGE OF ZONE

A. If a request for a change of zone is filed pursuant to the provisions of Article 1, Division 2, a fee shall become due and payable which shall be calculated according to the provisions of Section 102.0805.

B. No ordinance to change an existing zone shall be considered for adoption by the Council until the fee provided for herein has been deposited with the City of San Diego.

C. The provisions of this section shall not be applicable when the ordinance changing the zone requires that a subdivision map be filed in order to make the zone change effective.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
