AN ORDINANCE AMENDING ORDINANCE NO. 10584 (NEW SERIES), AS AMENDED, TO CREATE THE CLASSIFIED POSITIONS OF CHEF AND COOK AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 10584 (New Series) of the ordinances of The City of San Diego, as amended, is hereby amended to create and establish the classified positions of Chef and Cook.

Section 2. As the schedule of compensation for the positions created in Section 1 hereof, the following standard rate numbers of the Table of Standard Rates of Pay established and adopted by Ordinance No. 10584 (New Series), as amended, of the ordinances of said City, are hereby adopted.

Chef	30.5
Cook	28.5

Section 3. The positions of Chef and Cook shall be inserted in Exhibit B of Ordinance No. 10584 (New Series), as amended, under the general category of POLICE between the positions of Senior Identification Technician and Identification Technician.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
