AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING
SUBSECTION e OF SECTION 86.09 REGULATING
STANDING OR PARKING OF VEHICLES.

BE IT ORDAINED, by the Council of The City of
San Diego, as follows:

Section 1. That Chapter VIII, Article 6 of the
San Diego Municipal Code be and it is hereby amended
by amending subsection e of Section 86.09 to read as
follows:

SEC. 86.09 STANDING OR PARKING IN SPECIFIED PLACES
PROHIBITED.

No person shall park or stand a vehicle:

a. Within fifty (50) feet in advance of a
Stop sign, Yield sign, traffic signal, or marked
crosswalk when designated by appropriate signs or
markings.

b. Within fifty (50) feet of the prolongation
of an intersecting roadway curb or pavement edge
when appropriate signs or markings are in place,
except buses at a designated bus zone.

c. In any designated taxicab zone, except
properly licensed taxicabs.

d. In such a manner as to obstruct the free
use of the street.

e. In violation of any sign or curb marking
established pursuant to the provisions of the

San Diego Municipal Code.
