AN ORDINANCE ESTABLISHING A UNIFORM 24-FOOT BUILDING SETBACK LINE ALONG THE SOUTHERLY SIDE OF NORTH PARK WAY, BETWEEN RAY STREET AND I-805 FREEWAY, IN THE CITY OF SAN DIEGO, CALIFORNIA.

WHEREAS, a public hearing was held before the Planning Commission for the purpose of determining the advisability of recommending to the City Council the establishment of a uniform building setback line along the southerly side of North Park Way, between Ray Street and I-805 Freeway; and

WHEREAS, the City Planning Commission has heretofore recommended that said setback be established; and

WHEREAS, the Planning Commission and the City Council of The City of San Diego have found that the establishment of said uniform building setback line will promote public safety, health and welfare, will not adversely affect adjacent properties, and is necessary to conserve the value of said property; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. There is hereby adopted and established a uniform 24-foot building setback line along the southerly side of North Park Way, between Ray Street and I-805 Freeway.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its pasage.
