AN ORDINANCE INCORPORATING THOSE CANYON AREAS LYING EASTERLY OF DRAPER AVENUE AND DOWLING DRIVE, SOUTHERLY OF NAUTILUS STREET AND NORTHERLY OF CAMINO DE LA COSTA AND LA JOLLA RANCHO ROAD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO LC ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Those canyon areas lying easterly of Draper Avenue and Dowling Drive, southerly of Nautilus Street and northerly of Camino De La Costa and La Jolla Rancho Road, in the City of San Diego, California, within the boundary of the district designated "LC" on Zone Map Drawing No. C-328, filed in the office of the City Clerk as Document No. 737666 be, and they are hereby incorporated into LC Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
