

ORDINANCE NO. 10754
(New Series)

DEC 30 1971

AN ORDINANCE INCORPORATING PORTIONS OF BLOCKS 8 AND 9, LOMA ALTA NO. 1 AND PORTIONS OF PUEBLO LOT 206, PUEBLO LANDS, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 31 (NEW SERIES), ADOPTED SEPTEMBER 6, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That portions of Blocks 8 and 9, Loma Alta No. 1 and portions of Pueblo Lot 206, Pueblo Lands, in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing No. B-2560, filed in the office of the City Clerk under Document No. 738055 be, and it is hereby incorporated in R-2A Zone, as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 31 (New Series), adopted September 6, 1932 of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
