ORDINANCE NO. 10756
(New Series)

AN ORDINANCE INCORPORATING A PORTION OF PARCEL A, GENESEE GARDENS ADDITION, AND A PORTION OF PUEBLO LOT 1199, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 3729 (NEW SERIES), ADOPTED MAY 4, 1948, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a parcel map is recorded on a portion of Parcel A, Genesee Gardens Addition, and a portion of Pueblo Lot 1199, in the City of San Diego, California, designated "CO" on Zone Map Drawing No. B-2561.1, the provisions of Section 101.0423 of the San Diego Municipal Code shall attach and become applicable to the said land and shall be incorporated into CO Zone, as described by Section 101.0423, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2561.1, filed in the office of the City Clerk as Document No. 738059.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 3729 (New Series), adopted May 4, 1948, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.
