

ORDINANCE NO. 10757

AN ORDINANCE INCORPORATING PORTIONS OF LOTS 8 AND 9, BLOCK 12, AMERICAN PARK ADDITION AND A PORTION OF THE ATCHISON, TOPEKA AND SANTA FE RAILROAD RIGHT-OF-WAY, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CS ZONE, AS DEFINED BY SECTION 101.0432 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 100 (NEW SERIES), ADOPTED DECEMBER 12, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Lots 8 and 9, Block 12, American Park Addition and a portion of the Atchison, Topeka and Santa Fe Railroad Right-Of-Way, in the City of San Diego, California, within the boundary of the district designated "CS" on Zone Map Drawing No. B-2548, filed in the office of the City Clerk under Document No. 737970 be, and they are hereby incorporated in CS Zone, as such zone is described and defined by Section 101.0432 of the San Diego Municipal Code.

Section 2. That Ordinance No. 100 (New Series), adopted December 12, 1932, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
