

RESOLUTION NO. 201591 JAN 5 1971

WHEREAS, Section 22.0101 (a) of the San Diego Municipal Code provides for regular meetings of the City Council to be held each Tuesday and Thursday of each week at 9 a.m.; and

WHEREAS, the Council is of the opinion that by holding the regular Council meetings at 9:30 a.m. rather than 9 a.m. the Council could better utilize its time for preparation for Council meetings; and

WHEREAS, the Council is not desirous of changing the regular Council meeting time pursuant to ordinance until a brief trial period has demonstrated the feasibility of beginning regular Council meetings at 9:30 a.m. rather than 9 a.m.; and

WHEREAS, Section 22.0101 (b) of the San Diego Municipal Code provides that the Council may by resolution, when necessary, change the time of regular meetings; and

WHEREAS, the Council desires, on a trial basis, to hold the regular Council meetings on each Tuesday and Thursday of each week for the period of time beginning January 12, 1971 and ending March 11, 1971, at the hour of 9:30 a.m. rather than 9 a.m.; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the regular meeting of the City Council shall be at 9:30 a.m. of each Tuesday and each Thursday of each week for the period of time beginning January 12, 1971 and ending March 11, 1971.

BE IT FURTHER RESOLVED, that the City Clerk be directed to publish this resolution once in the City official newspaper at least twenty-four (24) hours prior to the meeting to be held on January 12, 1971.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to give each Councilman written notice, personally or by registered mail, of the change in regular meeting times established by this resolution at least twenty-four (24) hours prior to the first meeting to be held on January 12, 1971.
