BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Council resolution as follows:

1. Accepting the low bids, bids and authorizing the City Manager to enter into contracts for the purchase of AUTOMOTIVE EQUIPMENT FOR POLICE, FIRE AND PUBLIC WORKS DEPARTMENTS as follows:
  - a. Center City Motors (Ford) for Section I, Items 1 and 2: seventy-three (73) sedans for a cost of \$2,898.00 each, for a total cost of \$211,554.00 net, plus sales tax, less trade-in allowance of an estimated \$37,950.00 for an estimated total of seventy (70) sedans;
  - b. Lemon Grove Chrysler Plymouth for Section III, Item 1: one (1) four-door sedan for a cost of \$4,485.98 net, plus sales tax, and;
2. That all bids theretofore received on December 8, 1970 pursuant to publication of notice calling for bids on the purchasing of Automotive Equipment for Police, Fire and Public Works Departments, Section II, are hereby rejected.
