WHEREAS, Resolution No. 184420, adopted July 29, 1965, assured the Federal Government that The City of San Diego would assume responsibility for the required contribution of 17.8% of the cost of construction of the Tia Juana River Flood Control improvements then estimated at \$2,250,000; and

WHEREAS, the local share of construction costs has been reduced to 16.1% as a result of the Federal Government's expansion of the U. S. Naval Air Station Imperial Beach (Ream Field); and

WHEREAS, communications have been received from the International Boundary and Water Commission, United States and Mexico requesting that the City reaffirm its support of the project and its financing commitment which is now estimated at \$4,100,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Resolution No. 184420, adopted July 29, 1965, be amended to read as follows:

"The City of San Diego agrees to assume responsibility for the required contribution to the Federal Government of 16.1% of the cost of construction of the recommended Tia Juana River Flood Control improvements. The contribution, presently estimated at \$4,100,000 (final amount to be

computed after actual costs have been determined), will be paid as determined by City, either in a lump sum prior to commencement of construction or in installments prior to commencement of pertinent work items, in accordance with construction schedules approved by the United States Commissioner, International Boundary and Water Commission, United States and Mexico."
