WHEREAS, the need for improving freeway access to Lindbergh Field has been recognized; and

WHEREAS, the California Division of Highways has suggested several alternative methods for improving access; and

WHEREAS, the California Division of Highways is staffed to provide technical assistance in performing an in-depth feasibility analysis for improving access to Lindbergh Field; and

WHEREAS, the Board of Port Commissioners has indicated their desire to utilize the technical assistance of the California Division of Highways in conducting a comprehensive review of freeway access to Lindbergh Field; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council requests the technical assistance of the California Division of Highways to conduct an in-depth feasibility study of alternative means of providing direct freeway access to Lindbergh Field on behalf of itself and the San Diego Unified Port District.
