

RESOLUTION NO. 201687 JAN 21 1971

WHEREAS, BARNABY PRODUCTIONS, a California corporation, is considering the City of San Diego as a location suitable for the purpose of video taping and televising the Andy Williams Show during the week of January 24 through January 30, 1971; and

WHEREAS, The City of San Diego is interested in securing national publicity that the City of San Diego would enjoy by having said Show produced and video taped in the City of San Diego; and

WHEREAS, BARNABY PRODUCTIONS represents that it is planning and preparing to stage said Show in such a manner as to give national recognition to the City of San Diego and favorable publicity of the various advantages and opportunities afforded those seeking a place to enjoy recreational and vacation facilities; and

WHEREAS, the City will finance the amounts obligated to be expended by it under this contract as a promotional enterprise under the Transient Occupancy Tax Fund under Ordinance No. 9033 (New Series), adopted June 9, 1964, as amended, now in effect; NOW, THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City,

an agreement with BARNABY PRODUCTIONS, a California corporation, to prepare and stage the Andy Williams Show at the Civic Theatre, January 26, 1971, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 734568.

BE IT FURTHER RESOLVED, that the expenditure of \$60,000 is hereby authorized out of Fund 223, Function 52.43, Special Promotional Programs, solely and exclusively for the purpose of providing funds for the above described Andy Williams Show.
