Buildings & Facilities Div.	\$140	Mr. Minter proposed over two years ago that light fixtures at recreation centers and public restrooms be made vandal-proof. A program was begun to change all such fixtures. Longer life bulbs were also used as he suggested. It is estimated that about \$1,400 a year is saved in bulbs and labor. Also saved are some fixtures and maintenance. The use of vandal-proof fixtures is now the established policy.
