

RESOLUTION NO. 201703 JAN 26 1971

RESOLUTION DECLARING THE COUNCIL'S INTENTION TO  
ORDER CHANGES AND MODIFICATIONS IN THE WORK PROPOSED  
TO BE DONE UNDER RESOLUTION OF INTENTION NO. 200030,  
IN THE MATTER OF THE CONSTRUCTION OF VICKERS STREET.

WHEREAS, this City Council did, on June 16, 1970, adopt  
Resolution of Intention No. 200030 declaring its intention  
to order the construction of certain improvements as more  
fully described therein, and on the plans, profiles and  
drawings therein referred to, and did provide for the costs  
of said work to be assessed against the district described in  
said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity  
require that certain changes and modifications be made in  
the proposed work to be done under said Resolution of Intention;  
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

1. That the public interest, convenience and necessity  
require and it is the intention of the City Council of The  
City of San Diego, to order the following changes and  
modifications to be made in the work proposed to be done, as  
described in Resolution of Intention No. 200030 as follows:

Changing the size of the 14 copper water services from one  
inch water services as called for in the bid proposed for the  
aforesaid improvement, to one and one-half inch water services

as called for in the construction plans for said improvement, as more particularly shown on City of San Diego Engineering Department Drawing Nos. 11863-1-D and 11863-2-D, filed in the office of the City Clerk as Document No. 732217.

The estimated increase in the cost of the work by reason of the aforesaid proposed changes or modifications is the sum of \$2,345.00.

2. NOTICE IS HEREBY GIVEN, that MAR 4 1971

at 9:30 o'clock a.m. in the Council Chamber of the City Building, Community Concourse, 202 "C" Street, in the City of San Diego, California, are hereby fixed as the time and place when and where any and all persons having any objections to the proposed changes and modifications herein proposed may appear and show cause why said changes and modifications should not be done and carried out in accordance with this Resolution of Intention to Modify.

3. That the Clerk of said City be, and he is hereby directed to cause this Resolution of Intention to be published at least ten (10) days before the date of said hearing in the City official newspaper.
