That the expenditure of \$142,300 is hereby authorized out of Gas Tax Fund 219 of The City of San Diego, solely and exclusively for the purpose of providing funds for City's contribution toward the cost of the improvement of CORONADO AVENUE, between the northerly extension of the westerly line of Gibson's Corner, Map No. 5755, and the westerly City of San Diego boundary, under the 1911 Act proceedings.
