That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Beverly A. Brandon	WATER UTILITIES DEPARTMENT	\$75	Formerly when water meters were changed in size it was assumed that a new account must be assigned. As a result of this suggestion, this procedure has been eliminated as few changes actually are necessary, and these can be made otherwise. It is estimated that \$726 per year in clerical time and form cost will be saved.
Ronald H. Ogden	FIRE DEPARTMENT	\$60	Mr. Ogden designed and made a special clamp to remove valves from air bottles to be tested. This eliminated the 100% breakage that formerly occurred. About \$600 a year is saved in the cost of valves and in the labor for their removal.
Robert S. Kruger	WATER UTILITIES DEPARTMENT	\$50	It was proposed that various maps made by Utilities be charged for as are those made by Engineering. It is expected that there will be a net annual revenue of about \$1,100.
Donald J. Jewell	PARKS & PUBLIC BUILDINGS DEPT.	\$25	Suggester proposed adjustable metal forms be used for concrete around the bases of cemetery monuments. These replace special wooden forms that could be used only once. \$250 a year in material and labor is saved.
Eugene J. Spaeth	PUBLIC RELATIONS DEPARTMENT	\$20	Special portable tables for material were designed by the suggester. These make operations in the Print Shop more efficient and permit much better use of space in the shop.



Christine G. Gee	AUDITOR COMPTROLLER	\$15	A Rol-O-Dex file system was suggested for the record of employee car mileage authorizations. This saves an estimated \$150 a year in clerical work.
DeLeon Clayton	PUBLIC WORKS DEPARTMENT Equipment Division	\$10	It was suggested that holes be made in Mobil sweeper brake housings through which the brake linings can be checked. It is estimated that when this has been done on all 16 sweepers there will be an annual saving of over \$550 a year.
Beth L. Johnson	WATER UTILITIES DEPARTMENT Customer Service Division	\$10	It was proposed that Xerox be used to make copies of a special listing rather than by computer. This will save \$104 in clerical time and paper.
