BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of DEWEY L. DAVISSON and ANNA P. DAVISSON, husband and wife, as community property, executed in favor of The City of San Diego, bearing date December 11, 1970, conveying to said City an easement and right-of-way for street purposes through, over and across a portion of 5 Acre Lot 1 of Reiner's Subdivision of Pueblo Lot 1103, according to the map thereof filed in the Office of the San Diego County Recorder in Book 1, Page 184 of Deeds, as more particularly described in said deed, as certified by the Property Director be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named HOTEL CIRCLE PLACE.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
