BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of RICHARD F. LUSTIG and JANE LUSTIG, husband and wife; EDWARD PLATT and LOIS PLATT, husband and wife; PAUL M. THOMAS, JR. and ELOISE F. THOMAS, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date November 18, 1970, conveying to said City an easement and right-of-way for street purposes through, over and across a portion of Pueblo Lot 276 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, as more particularly described in said deed, as certified by the Property Director be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named HANCOCK STREET.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
