BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SGB CORPORATION, a California corporation, executed in favor of The City of San Diego, bearing date December 11, 1970, conveying to said City an easement and right-of-way for sewer purposes, through, along and across a portion of Pueblo Lot 1777 of the Pueblo Lands of San Diego, according to the map thereof made by James Pascoe in 1870, a copy of which said map was filed in the Office of the County Recorder of said County, November 14, 1921, and is known as Miscellaneous Map No. 36, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
