RESOLUTION No. 201750

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of BRIGHAM YOUNG UNIVERSITY, a Utah corporation, as to an undivided 20% interest; and GEORGE A. BJORKLUND and DAVID B. HAIGHT, Trustees, and their successor trustees, of the GEORGE A. AND ALICE N. BJORKLUND MEMORIAL TRUST FUND with BRIGHAM YOUNG UNIVERSITY, as to an undivided 80% interest, executed in favor of The City of San Diego, bearing date September 14, 1970, conveying to said City an easement and right-of-way for water purposes, through, along and across a portion of the West Half of the Northwest Quarter of the Southwest Quarter of Section 11, Township 14 South, Range 3 West, San Bernardino Base and Meridian, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
