BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of FRANK M. KELLER and MARJORIE KELLER, husband and wife, an undivided one-third interest; JOSEPH M. LONG and VERA MAI LONG, husband and wife, an undivided one-third interest; and THOMAS J. LONG, a married man, as his sole and separate property, an undivided one-third interest, executed in favor of The City of San Diego, bearing date October 12, 1970, conveying to said City an easement and right-of-way for water purposes, through, along and across a portion of the North Half of the Northeast Quarter and the Northeast Quarter of the Northwest Quarter of Section 16, Township 14 South, Range 3 West, San Bernardino Base and Meridian, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
