RESOLUTION No. 201756

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of TITLE INSURANCE AND TRUST COMPANY, a Corporation as Trustee under HA. H. NO. 118, executed in favor of The City of San Diego, bearing date August 18, 1970, conveying to said City an easement and right-of-way for water purposes, through, along and across a portion of the North Half of the Southeast Quarter of Section 12, Township 14 South, Range 3 West, San Bernardino Base and Meridian, according to U. S. Government Survey approved August 14, 1876, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
