SHEDD, husband and wife as joint tenants as to an undivided one-half interest; and ARCHIBALD MC LARTY and CATHERINE MC LARTY, husband and wife as joint tenants as to an undivided one-half interest, executed in favor of The City of San Diego, bearing date October 30, 1970, conveying to said City an easement and right-of-way for water purposes, through, along and across a portion of the East Half of the Northwest Quarter of the Northwest Quarter of the Southwest Quarter of Section 17, Township 14 South, Range 3 West, San Bernardino Base and Meridian, according to the United States Government Survey, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
