RESOLUTION No. 201763

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of HERBERT R. YOST and LEONA A. YOST, husband and wife as community property, executed in favor of The City of San Diego, bearing date October 27, 1970, conveying to said City an easement and right-of-way for water purposes, through, along and across a portion of the Southwest Quarter of the Northeast Quarter of the Southwest Quarter and the North Half of the Southwest Quarter Easterly of the centerline of the unnamed County road, all in Section 18, Township 14 South, Range 3 West, San Bernardino Base and Meridian, according to United States Government Survey approved August 14, 1876, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
