

RESOLUTION NO. 201782 JAN 28 1971

WHEREAS, the National Electrical Contractors Association, Inc., Local Union 569, International Brotherhood of Electrical Workers, and the San Diego Gas & Electric Company desire to assist the City in improving and beautifying Presidio Park in conjunction with their celebration of the anniversary of Thomas Edison's birthday, February 11; and

WHEREAS, said organizations have generously offered to donate to the City of San Diego and install the permanent lighting facilities to light the statue "El Charro" in said Park, the value of which donation is approximately \$5,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

and does hereby publicly express on behalf of the citizens
