

RESOLUTION NO. 201791 FEB 2 1971

WHEREAS, a petition and a supplemental petition were received by the City Clerk for the formation of a park district under the provisions of the San Diego Park District Procedural Ordinance of 1969, said petition being filed in the office of the City Clerk on January 20, 1971 as Document No. 734580 and said supplemental petition being filed in the office of the City Clerk on January 25, 1971 as Document No. 734581; and

WHEREAS, these petitions have been checked by the City Clerk; and

WHEREAS, the City Clerk has certified in a certificate filed in his office on January 26, 1971 as Document No. 734614 that the petitions contain signatures representing 60.4% of the area of the assessable lands in the proposed district as shown by the last equalized assessment roll upon that date; and

WHEREAS, the City desires to acknowledge the petitions for said district; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the receipt of the petition and the supplemental petition for the formation of a park district under the provisions of the San Diego Park District Procedural Ordinance of 1969 in the South Mission Hills area, on file in the office

of the City Clerk as Document No. 734580 and Document No. 734581, respectively, are hereby acknowledged.

2. That the City Engineer and the Property Director are hereby directed to prepare plans for the acquisition, improvement and maintenance of the lands shown on Exhibit A of said petitions, together with the estimates of the costs and expenses of such acquisition, improvement and maintenance, to prepare an estimate of the assessment to be levied on each parcel of property within the proposed district, and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for said acquisition, improvement and maintenance; said acquisition, improvement and maintenance to be done under the San Diego Park District Procedural Ordinance of 1969.
