COOK, Registered Civil Engineer, and entitled, "VILLA PORTOFINO UNIT NO. 2 Being a subdivision of a portion of Lots 23, 24 and 25 of Rosedale Tract according to Map thereof No. 825, and also a portion of the Re-subdivision of Lots 14, 16, 18, 19 and 20 of Rosedale Tract according to Map thereof No. 857, all in the City of San Diego, County of San Diego, State of California, copies of said maps being on file in the office of the County Recorder of said San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and the alleys, to wit: Porto Court and Fino Drive and the alleys for public purposes and said streets and alleys are hereby declared to be public streets and alleys and dedicated to the public use.
