

RESOLUTION NO. 201800 FEB 2 1971

APPROVING MAP OF VILLA PORTOFINO UNIT NO. 2
AND ACCEPTING ON BEHALF OF THE PUBLIC THE
PUBLIC STREETS AND THE ALLEYS DEDICATED ON
SAID MAP AND ACCEPTING ON BEHALF OF THE CITY
OF SAN DIEGO THE EASEMENT AS GRANTED ON THIS
MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed
by E. F. COOK, Registered Civil Engineer, and entitled, "VILLA
PORTOFINO UNIT NO. 2 Being a subdivision of a portion of Lots
23, 24 and 25 of Rosedale Tract according to Map thereof No. 825,
and also a portion of the Re-subdivision of Lots 14, 16, 18, 19
and 20 of Rosedale Tract according to Map thereof No. 857, all
in the City of San Diego, County of San Diego, State of California,
copies of said maps being on file in the office of the County Recorder
of said San Diego County.", is made in the manner and form prescribed
by law and conforms to the surrounding surveys; that said map and
the subdivision of land shown thereon is hereby approved and accepted;
and said Council hereby accepts on behalf of the public, the public
streets and the alleys, to wit: Porto Court and Fino Drive and
the alleys for public purposes and said streets and alleys are
hereby declared to be public streets and alleys and dedicated to
the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego the open space easement over all of Lots 99, 100, 101 and 102 granted on this map, subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and alleys are accepted on behalf of the public as heretofore stated; and that that certain easement for open space as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
