

RESOLUTION No. 201804

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of LORNE FROATS and ANNE FROATS, husband and wife as joint tenants as to an undivided one-half interest, CHLOE S. DAHLE, Trustee, and her successors as Trustees of the Dahle Family Trust, a declaration of trust executed September 18, 1968, executed in favor of The City of San Diego, bearing date August 19, 1970, conveying to said City an easement and right-of-way for water purposes, through, along and across a portion of the Northeast Quarter of the Northeast Quarter of Section 13, Township 14 South, Range 3 West, San Bernardino Meridian, according to the United States Government Survey, approved August 14, 1876, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
