That the acceptance by the City Manager of that deed of ROBERT H. HALLE and MILDRED K. HALLE, husband and wife, as joint tenants, executed in favor of The City of San Diego, bearing date November 30, 1970, conveying to said City an easement and right-of-way for water purposes, through, along and across a portion of the Southeast Quarter of the East Half of the Northeast Quarter of the Northwest Quarter of Section 23, Township 14 South, Range 3 West, San Bernardino Meridian, according to the United States Government Survey, approved May 20, 1884, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.
